My dear Dr. Reyes:

A good friend of mine, Professor William Maynard, who is on leave from Dartmouth College and who is now in Mexico, gave me your name as being probably the best person from whom I might discover whether there is a Mexican Philosophical Association and if so, who its officers are.

The American Philosophical Association has voted to invite the philosophers in America to a hemispheric congress of philosophy, probably to be held in 1942. There was to be an international congress of philosophy in Holland this year (this time and date was decided at the last international congress held in Paris in 1937). It is clear that the unfortunate events in Europe make the international congress of philosophy impossible for this year. The possibility of a Pan American congress, therefore, seemed the more appealing. We should naturally like to get as good a representation as possible from Mexico and the countries lying to the south. I would, then, be very appreciative of any information you could give me with regard to who would be the best people to write to about this matter.


