Dear Mr. Weinstock:

I am reading just now your good letter of March 3rd., as I was abroad for a while.

You are right: I never answered your letter of November 30, 1964 for the unpolite but quite convincing reason that I had little or nothing to say about it.

The information given to you by Frank Tannenbaum is not entirely correct. Of the Historia Moderna de México proper there remains to be published (and wirtten) the ninth volume. This, I presume, will take me the rest of this year and all the next. In 1967 I will write a resumé of this work: a book of no more than 500 pages, without any notes or scholarly apparatus, and written not only clearly, but with real literary polish. But naturally, this volume will cover the same period as the big work, that is 1867-1911.

What Frank does not know (and nobody knows) is that I have signed an agreement with a French publisher to write within a year a book entitled Mexico in the XX Century, that is, from 1900 to, say 1950 or 1960. It is a rather short work (some one hundred pages), but as I am lecturing next year at Harvard on the same subject, I imagine the Spanish original may go up some 50 pages more.

I have a great faith in these two ventures and I hope that some American publisher may share my opinion. As a matter of fact, two American university presses have already approached for the publication rights of the first book. I have made not commitments so far, partly because it seems to me a bit premature, and partly because I would certainly prefer to deal with a "commercial" publisher to handle a book which properly handle may reach quite a number of readers.

I do not know whether you may be interested in the volume on Mexico in the XX Century, and if so, I would like to see your first reactions,
