Alejandro Garza Balmori, a former federal prosecutor will take over as his deputy, replacing Farfan's deputy, Raul Rivera Molina who was also killed in last week's attack. 5. (S/NF) Local media has rolled over and printed the Zetas-approved version of events both about the killing and about a subsequent narco manta incident (see below). El Manana, which should be the newspaper of record, has abdicated its responsibility, due to deadly attacks on its staff several years

ago. The Texas media, led by the Laredo Morning Times, whose stories are largely accurate, has filled the gap. El Norte apparently published an article about the assassination that had not been vetted by the Zetas, only to see the trucks delivering copies of that edition seized upon their arrival in Nuevo Laredo on Feb. 5. The driver had a gun put to his head and was told that from now on, "the news from Nuevo Laredo will stay in Nuevo Laredo." The gunmen then set fire to the entire load. El Norte has subsequently moved their one local reporter from Nuevo Laredo to Monterrey (she then resigned), and will no longer distribute their paper in Nuevo Laredo.

6. (S/NF) More details have come out about the Feb. 1 incidents that resulted in approximately two dozen children being taken to the local Child Protective Services (DIF) by Municipal Police.

However, the kidnappings were carried out at the time of morning when parents were taking their children to school, resulting in unplanned childnappings. In some cases, the children were left at the scene, where relatives and friends could aid them. In other cases, the children were taken with the kidnappers, but released soon after. The Municipal Police claim that they found many of them wandering the streets,

This was a public relations disaster for the Zetas, who like to project an image as local boys who protect the populace. It also played into local fears for the safety of children during this conflict. Widely reported in the Texas media, it also fueled Texans' fears of being kidnapped if they come to Nuevo Laredo. (NOTE: During the six weeks of relative tranquility after the November beginning of the Northeast Campaign, P0 met B1
