Dear Dr. Reyes:

I have the honor to inform you that at a meeting of the Executive Committee of The Rockefeller Foundation on September 27, 1957, action was taken providing up to \$39,000 / to El Colegio de Mexico toward the support of a research and training program in literary studies. This sum is available during the three-year period beginning November 1, 1957.

It is our understanding that the proposed program will require an annual budget of \$19,500, of which one-third will be provided by El Colegio de Mexico, and two-thirds will be provided by the Foundation's appropriation.

We shall be glad to make payments on this grant on a semi-annual basis upon receipt and acceptance of a budget for the project at the beginning of each fiscal year of the appropriation. We shall appreciate receiving also annual statements of receipts and expenditures. Any balance of the fund unexpended on October 31, 1960, will revert to the Foundation.


A brief public announcement of this grant will be made in the next quarterly report of the Foundation. There is, however,


Dear Miss Rhind:



Dear Daniel:

Thank you for your letter of June 7. I am sorry that apparently action was deferred on your letter of March 31 to Jack Harrison. Perhaps you know that he had a rather prolonged spell of illness in April and this probably accounts for action having been neglected.

I am taking steps to extend the terminating date of RF 57155 in support of research and training in literary studies to October 31, 1961. I see no reason for any difficulty in this extension - the reasons you give are thoroughly valid ones. I suggest that you plan the budget that you expect to present later this month on the assumption that the grant will be extended.

There is a little confusion as to the new terminating date. Your letter of March 31 requests extension to June 30, 1961, while your letter of June 7 requests extension to December 31, 1961. Since our regulations permit an extension by officer action of only one year and the present terminating date is October 31, 1960, I am recommending extension to October 31, 1961, in the hope that this intermediate date will meet your needs. If a further extension is required, we would have to present the question to our Trustees.




