John Holmes

June 30 1921.

My dear Gen. Ryan-- I fear that you misunderstood several of the things I said to you in regard to Col. Rivera's efforts in our behalf. He comes to us tonight to say that Mr. Torreblanca accuses him of deserting us to go joy-riding and of other errors too numerous to mention. In telling you that the Colonel had --at our request taken the trouble to find and invite into his car the three young ladies to lend beauty and interest to the Corso of last Sunday--I was merely trying to make clear the necessity of having some sort of card or permit for Mr. Cowling to identify him with the police in the momentary and necessary absences of our chaperon. The Colonel's attitude in this matter was perfectly correct and assumed at our request.

The trouble is the the Palace authorities will not give even ten minutues of undivided attention to the Colonel and that no one has yet been able to lead them to understand the true situation. We have no complaints to make as to his kind attentions to us but we do find it difficult to accomplish anything in the line of the work we have come to do--when we are forbidden to operate without his presence and when his presence is required at the palace in vain efforts to secure some definite instructions and the means to carry them out. As it now stands Mr. Torreblanca refuses to listen to the Colonel until you O.K. the account which he seems to think that you and I have questioned. I personally have no doubt but that every item is correct ---my only concern was to avoid any future expenditures on the same scale and to assure the authorities that they need not so lavishly provide for what are really very simple needs. Apparently my effort to make things easier for our kind sponsors at the Palace has led to misunderstandings which are most unfortunate. The whole situation is now at a standstill---the Colonel and his brother and friends feel that he has been misrepresented and Mr. Torreblanca temporarily washes his hands of the matter---and there we are ---- It would seem to me that ten minutes straightforward talk with the proper official would clear up everything--But we have been six days in trying to reach and failing to reach any definite understanding--and meantime the sun shines and time flies and the Colonel is kept waiting vainly at the Palace--and the work we hoped to do for Mexico does not get done--- How can I get somethi

thing in black and white or had I better give up the effort and go home


