

Dear Dr. Cosio Villegas:

Thank you for your letter of September 29. We are now processing Rolls 1, 2, and 10-47 of Microcopy 274 for you. This film should be ready for mailing within a month.

The bound chronological series of instructions and despatches ends in 1906. From 1906 to 1910 most incoming and outgoing correspondence and other non-routine papers were arranged by subject in a single numerical series. In 1910 the system of assigning consecutive case numbers to subjects was abandoned in favor of a decimal system of subject classification. There will, therefore, be a gap of approximately four years in the records available on film as we do not plan, at least for the present, to film the "numerical file."

We will be glad to inform you as additional segments of the decimal file become available on film.
