Dear Dr. Rees:

Our mutual and good friend, Mr. Rodolfo Calle, instructed me to write this letter to you explaining his throat troubles of recent date and seeking your advice in connection with his final decision on this matter.

Yesterday, Mr. Calles, suddenly found himself afflicted by the same hoarseness of voice he experienced before you operated on him. He immediately went to see Dr. J.
