

My dear Mr. Beal:

Your kind letter of July 15th and your remittance for \$9,425.00 the receipt for which you shall find herewith.

I would like to be sure that your statement both in your letter and in your voucher N° 48566 that this is the second semi-annual installment for the year 1948 under your appropriation RF 48033 is a lapsus. This payment is in fact the first one as your appropriation for advanced study and training of personnel starts July 1st., 1948.

As the further information you want from us, it is as follows:

We now have ten fellows in our Center for Literary Studies each one receiving a yearly fellowship on 4,200 (Mex.Cy.), and the whole cost (42,000 Mex.Cy.) is charged to the Foundation.


As for individual research grants, our commitments so far are for

5 grants of 3,600 (Mex.Cy.)	each, with a yearly cost of 18,000
1 grants of 4,200 (Mex.Cy.)	each, with a yearly cost of 4,200
2 grants of 5,400 (Mex.Cy.)	each, with a yearly cost of 10,800
3 grants of 6,000 (Mex.Cy.)	each, with a yearly cost of 18,000
6 grants of 7,200 (Mex.Cy.)	each, with a yearly cost of 43,200

As a total, then, we have 17 individual research grants with an annual cost of 94,200 (Mex.Cy.), and we charge the Foundation exactly half of that amount. Naturally, as we submitted to you this time just a semi-annual budget, it is to be understood that we will charge in 1948 to the Foundation a quarter of that sum.

Dear Mr. Beal:

May I refer to your last letter of October 20th.

There must be a misunderstanding as to the terms under which grants RF 44134 and RF 48033 are to be used by El Colegio. I would like then to make El Colegio's position as clear as possible in this letter, not only because otherwise it would seem that El Colegio is asking for funds unprovided for, but because assuming that our point of view was correct, El Colegio has made commitments which could hardly be met with its own funds.

We were advised by Miss Norma S. Thompson as to the terms for grant RF 44134 in her letter of December 6, 1944. According to that letter, action was taken by your Board of Trustees to provide up to \$56,520.00 for the work of the Center for Historical Studies during four years beginning January 1st, 1945, the amount to be available in each year of the period not to exceed \$14,130.00, and the grant to be used annually as follows: fellowships, \$ 4,800.00; research grants, \$ 6,830.00; books and journals, \$ 2,500.00.

According to these terms, we have been receiving from your office ever since January 1st, 1945, advanced quarters payments of \$ 3,532.50 each. If we did not

receive payments for the third and fourth quarters of this year, it was because we failed to send you a statement of receipts and expenditures for the calendar year 1947. Once we had your kind letter of July 13, 1948, on this point, we sent such statement in our letter of July 20.

As to grant RF 48033, we were advised as to its terms in a letter from the secretary's office of April 7, 1948. According to that letter, the fund of \$ 53,000.00 provided for, "is in addition to the Foundation's current grant to the Colegio (RF 44134), and is available until June 30, 1952, under the understanding that payments under both grants will not exceed \$ 17,000.00 in any one year".

We believed then that we were within the limit set forth (and that was apparently the only condition), if we were to receive \$ 7,065.00 under grant RF 44134 and \$9,425.00 under grant RF48033, as both quantities added up give \$ 16,490.00, —a sum lower than the \$ 17,000.00 limit.

If, as we hope, you find our point of view correct, we would like to receive payment for \$ 7,065.00 (third and fourth quarter payments for 1948) under grant RF 44134.

Dear Dr. Reyes:

This will acknowledge receipt of your letter of October 30th in reference to our appropriations RF 44134 and RF 48033 for your programs for advanced study and for training of personnel.


As you state in your letter, these two appropriations terminate on June 30, 1952, and it is understood that not more than \$17,000 will be available in any one year. During the current year the following payments have been made:

January 10, 1948	\$3,532.50
March 29, 1948	3,532.50
July 14, 1948	9,425.00

These total \$16,490, the amount which you have budgeted for the year 1948.

Appropriation RF 44134 was on the basis of the calendar year. However, as the new appropriation terminates June 30th, 1952, perhaps it is your desire to change from a calendar to a school year basis. If so, we can consider the first two payments in 1948 as the balance due for the year 1947-48 and the payment of \$9,425 as the first payment for the year 1948-49. If this be the case, you should send us either a budget for the period January 1 to June 30, 1949, which we will add to the budget presented for the last half of 1948, or a new budget for the full year 1948-49. On this basis the allotment for the year ending June 30, 1949, would be \$17,000, of which we have paid you \$9,425. The difference, or \$7,575, would be payable upon receipt of a new budget.

It seems that the terms of your grants RF 44134 and
48033 were so presented as to induce El Colegio to inter-
pret them in the wrong way.

+ We are extremely grateful for your suggestion to the
effect of changing from a calendar to a school year basis,
but we are afraid it would serve no useful purpose. We
will rather try to find some way out of the deficit posi-
tion in which El Colegio finds itself at present.

In order to avoid another mistake, I would appreciate
if you advise me at your earliest convenience 1) the top
amount for which El Colegio may present its budget for
the calendar year 1949 under appropriations RF 44134 and
RF 48033; 2) whether unused 7,065 dollars under appropia-
tions RF 44134 will be added up to the remaining (43,515
dollars) of appropriation RF 48033.


Dear Dr. Reyes:

We received your letter of December 4th and are sorry to hear there has been a misunderstanding in reference to the terms of our last appropriation, RF 48033.

Our first grant toward the work of your Center for Historical Studies, RF 44134, was for the four year period ending December 31, 1948, and the amount available each year was not to exceed \$14,130. In April 1948 an additional appropriation toward your programs for advanced study and training of personnel was made - RF 48033. This grant was made with the understanding that both RF 44134 and RF 48033 would be available to June 30, 1952 and that not more than \$17,000 would be expended in any one year.

During the current year, 1948, we have made three remittances to you totalling \$16,490. During 1949 payments totalling \$17,000 against the combined grants could be made upon receipt of a budget for this amount.



Dear Dr. Reyes:

I very much appreciate the thoughtfulness which prompted you to write me as frankly as you did on May 2. In acknowledging that letter I merely wish to deal with the apparent misunderstanding about payments under the Foundation's grants to the Colegio last year, deferring for the present any further comment on the request for further assistance for Dr. Lida's work. Certainly there should be no misunderstanding between us on any such question, and I hope that what I go on to say may serve to clear up the question in your mind about these payments of last year.

On receiving your letter, Mr. Beal, the Comptroller of the Foundation, kindly reviewed with the utmost care all payments made to the Colegio under the two current grants toward its programs for advanced study and for the training of personnel during the period ending June 30, 1952, i.e., RF 48033 "in addition to RF 44134."

I should perhaps make perfectly clear the meaning of the phrase "in addition to": it is a phrase used here to combine successive grants for the same purpose. There was, as you know, at the time RF 48033 took effect, a balance of \$7,065 in RF 44134. That balance then became an integral part of the combined grants.

In trying to see this from your point of view, we surmise that you had originally thought that \$14,130 under the original grant should have been paid during the year 1948 plus one-half of the amount available in a year under the new grant or \$8,500. It is clear, however, from your letter of October 30, 1948, that you understood that the total payments from both grants in any one year could not exceed \$17,000. Indeed, in that same letter you alluded to this, and pointed out that the total paid during 1948, \$16,490, was within this \$17,000 limit. Again, it is possible that you felt that the \$7,065 balance in the old grant under the prevailing arrangement was lost to you. But this is of course not the case. In combining the earlier grant with the later one, this \$7,065 remains as a part of the total available.

Perhaps we can best make this completely clear by again summarizing all payments made under these two grants, as indeed Mr.

This may be the time to point out that if this grant is to last until June 30, 1952, its present terminating date, the present annual budget rate will have to be materially reduced as the balance for the remaining two years and a half following 1949, \$33,640, would on an average allow payment at a rate of only \$13,456 a year.

I sincerely hope that this may serve to make the situation, as we see it, entirely clear to you, and should be happy to have from you word to that effect.


You will excuse me for answering so late
