It was a pleasure to meet Miss Bertha Ulloa Ortiz when she came to Smith College on December 18th, to inquire about the material in our Elizabeth Cutter Morrow Collection which relates to the period of Mexican history of which you are preparing a guide.

When Professor Potash of the University of Massachusetts first told me of your project and of the desire of Miss Ulloa to come to examine our Collection, I explained to him that this collection of personal papers of Mrs. Morrow is not now available to scholars, and that any inspection can be made only with the permission of Mrs. Morrow's daughters, Mrs. Aubrey Niel Morgan and Mrs. Charles A. Lindbergh.

Miss Ulloa arrived unexpectedly early and before response to the request for this permission had been received. I sympathized with her desire to obtain information while she was in this remote district to which she would not be able to return, and consequently, I took the responsibility of allowing her to look through a partial index of the material, and to verify the entries by checking on the original papers, under my supervision.

I wrote to Mrs. Morgan, at once, to report the visit of Miss Ulloa. Before my letter reached her, I received a letter from Mrs. Morgan, stating that she and Mrs. Lindbergh refuse permission to have Mrs. Morrow's papers seen, at this time, and enclosing a copy of her letter to you of December 16th.

I am, of course, distressed to have gone beyond my jurisdiction in allowing Miss Ulloa any specific information on the nature of the pertinent papers of Mrs. Morrow's Collection. I am sure, however, that both you and Miss Ulloa will understand the situation, and will, of course, respect the rights of the owners of the papers, and will allow no word to appear in your publication beyond the general statement of the existence of personal papers of Elizabeth Cutter Morrow in the Sophia Smith Collection of Smith College.

I have since heard again from Mrs. Morgan, who tells me that she does not object to the listing of the material <u>in the form in which it</u> <u>appears in our index</u>, provided that it be made clear that the material itself is not available to scholars without special permission. I judge that the purposes of your guide will be adequately served by the more general simple statement of the existence of personal material. Moreover, I wish to point out that the Elizabeth Cutter Morrow Collection contains a large amount of record of her period in Mexico which has not yet been recorded in our partial index which Miss Ulloa examined. If you wish to include the more specific information of the index entries, I must ask that you send me a copy of the passage for approval, before it is sent to print.

I do not know whether or not Miss Ulloa has returned from her interesting tour of inspection of libraries in the United States. Please give her my warm greetings, when she does return. I still hope to make a visit to Mexico before spring, and shall write to her as soon as my plans are definite.

Best wishes to you for your interesting project which will certainly be of good service to historians and research scholars in Mexican history!
