1. (SBU) Summary: On May 16, President Alvaro Colom declared a "state of siege" for the northern department of Peten for 30 days following the discovery of 27 decapitated people at a ranch on May 15. While it is not yet clear who is responsible for these crimes, authorities agree that witness statements and evidence left at the scene point toward the Los Zetas drug cartel. All USG agencies stand ready to assist the Government of Guatemala (GOG) in its investigation; NAS helicopters have already transported prosecutors and equipment to the crime scene and GOG agencies are jointly coordinating operations and checkpoints. The massacre follows a week of extreme violence throughout Guatemala and it is not yet clear which of these incidents may be interconnected. We have

taken all appropriate measures to alert Embassy personnel and U.S. citizens in country to exercise extreme caution when travelling in Peten., Media outlets widely condemned the heinous murders and most analysts believe this marks a new level of violence for Guatemala.

#### Peten Massacre

- (SBU) On May 16, in a televised address, President Alvaro Colom declared a "state of siege" for the northern department of Peten following the gruesome discovery of 27 decapitated people at the privately-owned "Los Cocos" ranch on May 15. (Note: The ranch is located approximately 87 miles to the west of Flores, the department capital.) The perpetrators of the massacre are believed to be associated with the Los Zetas drug cartel based in Mexico. Twenty-five men and two women were murdered; those who have been identified so far ranged in age from 13 to 44. They appear to be seasonal workers hired from the eastern Izabal and Zacapa departments to work at the ranch. Surviving witnesses reported that on May 15, in the early morning, 50 armed, uniformed men entered the ranch in 12 vehicles and gathered all ranch employees They demanded that the workers reveal the location of together. but the workers did not B6 the owner, provide this information. The men then began to kill and dismember the workers removing the heads of most victims and carving the letter "Z" into the torso of some. Brazen Violence on the Rise

9. (SBU) The Peten massacre took place during an especially violent period throughout Guatemala:

On May 2, there was a shootout on the CA13 highway just south of Poptun, Peten. The PNC had been dispatched to investigate an attempted kidnapping when they were shot at by alleged narcotraffickers. The assailants fled, but the PNC seized eight AK-47s, a rifle, munitions, bulletproof vests, four radios, and a military-style helmet.

On May 13, five people were killed and several people were injured while traveling on a bus from Quetzaltenango to Guatemala City at 7:30 a.m. Press reports indicate that armed men boarded the bus and began taking valuables from passengers. Differing accounts suggest that the thieves began indiscriminately shooting at passengers, or that one passenger, who was himself armed, resisted the thieves' demands and fired his gun which led to a firefight and the deaths of other passengers.

On May 14, Haroldo Waldemar Leon Lara, an alleged narcotrafficker and the brother of narcotrafficker Juan ("Juancho") Leon Lara who was murdered in Zacapa in March 2008, was killed in

San Jose, Peten.

reported that the shooting was taking place a block and a half away UNCLASSIFIED from its offices in Santa Elena. Rainforest Alliance also noted that CONAP (National Council for Protected Areas) had received a bomb threat.

10. (SBU) On May 17, GOG authorities arrested Hugo Alvaro Gomez Vasquez, a former military sergeant whom they believe to be linked to the kidnapping and eventual murder of Luis Carlos Bardales Chacon as well as the murders of his father and wife. GOG authorities theorize that all three were kidnapped by the Los Zetas cartel and that Salguero was being extorted to pay a ransom or that he owed the Los Zetas cartel money for drugs. Salguero's failure to pay may have resulted in their three deaths and may also have led to the Peten massacre on May 15. GOG authorities are still investigating. To date, the PNC seized three vehicles believed to have been used in the massacre, three kilos of cocaine, 150,000 Quetzales in cash (approximately \$19,740), bulletproof vests, and firearms, and identified a camp site used by the assailants in the jungle.

#### Media Reaction

(SBU) Initial reaction to the massacre in the media was unanimous in condemning the wanton violence and brutality of the attack, agreeing it marks a new low in a country already viewed as one of the most violent in the region, and is symptomatic of larger problems ailing Guatemala. Some columnists assert that with this massacre the Zetas are sending the clear message that they are a "force to be reckoned with" and are "here to stay." In reference to the U.S., leading daily Prensa Libre carried Ambassador McFarland's statement and condolences after the attack, while its lead editorial proclaimed that the scourge will continue until the U.S., as "the largest consumer market of narcotics," decides to penalize consumption as well as distribution of drugs, calling for international efforts to address the problem. While conservative business daily Siglo21 (on May 17) posited the negative effect the massacre will have on foreign investment and tourism, it joined several others on May 18 in pointing fingers at U.S. training of Mexican and Guatemalan special forces, making them attractive recruits for drug-trafficking organizations. (Comment: We have no information that U.S.-trained Mexican or Guatemalan special forces were involved in this incident. In fact, GOG authorities are extensively using police and military special forces to conduct operations against criminal groups in Peten. End Comment.)

## Embassy Security Posture

12. (SBU) The Consular Section issued a warden message on May 16 alerting U.S. citizens to the Peten massacre and urging them not to conduct any unnecessary travel and then sent another message on May

17, to inform about the declaration of the "state of siege" in Peten. One hundred twelve American citizens residing in Peten are registered with the Consular Section. The vast majority live in Flores/Santa Elena and Sayaxche. There were no reported injuries associated with the Peten massacre or the Santa Elena firefight. The Regional Security Office (RSO) also sent out a security notice on May 17 to all Embassy personnel urging them to exercise extreme caution when traveling in the Peten. Peace Corps has placed the Peten (where there are no PCVs) off-limits. In addition, all in-country travel by Embassy personnel (both personal and official) is reviewed by the RSO.

### Comment

13. (S/NF) Peten is the largest department in Guatemala that contains vast amounts of forests and farms with minimal government presence. Previous incidents of narcotraffickers operating with impunity there, including intimidating and coercing local residents into cooperating with them,
