Dear Professor Olson:

From time to time I have asked Professor Ross to give to you and Mrs. Olson our best regards, and the assurance that both Mrs. Cosío and myself enjoyed and appreciated your own company and Mrs. Olson's. This time I must write you directly because I have a little business to transact with you.

I do not know whether in the talks we had I referred to El Colegio de Mexico's plan to open this year a Center for International Studies. Anyhow, I am sending you under separate cover a copy of the Bulletin outlining the Center's purposes, its curricula, etc.

Our main idea has been that since we come so late in the field of International affairs, we must prepare our students as quickly and as directly as possible, to understand present-day international problems. Recognizing, however, that one cannot understand fully what is happening today without knowing something about what happened yesterday, the courses on international relations proper are preceded by a group of historical courses. So before coming to the course on the U. S. and the Western World, we will offer to our students the following historical courses: Latin America in the XIX century; The United States from 1865 to 1920, and Western Europe from 1870 to 1920. Before taking up the course on the Arab Nationalistic Movement, we have a course on Middle-East Culture, or before considering India Today, we shall teach our students what the classical Hindu Culture was.

We have invited professor J. B. Duroselle, from the Paris Institute of Political Studies, to lecture on the United States and the Western World; Professor Torval Höjer, from Sweden, will take the course about Modern Western Europe, and we would like to invite you to take charge of the course on The United States from 1865 to 1920.

This course will be given from February through June, next year, and consists of two one-hour lectures a week, which roughly means for the whole period some forty lectures. Then, we require our professors to be at El Colegio's offices from six to eight hours a week to talk with individual students to advise them about their readings, the papers they may prepare, etc., following in this kind of work rather the English tutorial system (By no means a Seminar). Finally, we would expect our professors to deliver some five or six public lectures, whether at El Colegio itself, or at the National or some provincial universities.

Our students (no more than 25) will be able by next year to understand perfectly well your lectures in English, and also to express themselves, both orally and in writing, although, of course, only fairly well. Whatever their difference as to age and training, they have in common a complete ignorance as to American history. So, we cannot think of a high level course. If I were to make a comparison, I would say that our course should be at the level of what you consider for "both undergraduate and graduate students". I believe that the conditions in which you would work here would be a real stimulating challenge, for, on the one hand, you cannot take for granted anything, as you certainly can with American students, and, on the other hand, being unable to go into details or exquisite refinements, you must keep a course on the central path of the American historical changes.

Some of the professors we are inviting —and that would be your particular case— would be paid through the Organization of American States, and the Organization's terms are: one air round trip, tourist class, and a salary of one thousand American dollars a month, or five thousand in this case.

You maybe talk with Dr. Ross about the cost of living in Mexico City and find out whether OAS's terms are convenient.

If you —as I earnestly hope— find no unsurmountable inconvenience, we may further correspond on whatever you wish, and specially, of course, as to a possible outline of your course, the bibliography you may need, etc. I am quite willing, if you so desired, to write chancellor Hardin, if that would help to ease some administrative arrangements.


Dear Lic. Cosío:

Dear Professor Olson:

Although I had the intention of being the first one to tell you that we had arranged satisfactorily the course on American History be given during the second semester, next year, I see that both professor Cuevas Cancino and Ross defeated my good intentions.

This sad fact reveals, however, that there is some organization in our Colegio, since Mr. Cuevas Cancino, as Director of the Center of Internacional Studies, is in immediate charge of all matters pertaining to the Center. As to professor Ross, it reveals the high esteem he has for you.

Professor Cuevas is right now in Venezuela. So I cannot check with him whether he told you we would like to have at your earliest convenience an outline of the topics to be covered in your course, and a bibliography of books you may need and of those that our students will be required to use. This question of the bibliography is rather urgent because in spite of having, as we do, funds available and good connections both with local and foreign book jobbers, it is incredible how slowly our orders come to the point of having the books in our shelves.

Since we are planning to build up a tolerably good library in American history, you may be somewhat liberal as to the number and nature of the books to be ordered. In regard to the bibliography for use of our students, you may have a rough idea as to what the reading requirements could be. We figure that our students will devote to your course some seventy two hours for outside reading, and this would mean some fifteen hundred pages.

I am sure that this problem of bibliography has been worked out by you along the years, and then that you may expend some time on the particular aspects it may have in our case during the coming summer recess you will have in few days.

Anyhow, please don't hesitate to ask us for any explanation you need.



Dear Luis:

I am sorry to have delayed in answering your letter of May 22, but things have been in a state of utter confusion here. First, Lee was hospitalized the last two weeks in May. I am happy to report that she is again home and feeling considerably better. Secondly, out of the blue came a job opportunity which just yesterday I accepted.

Beginning in September I will be Chairman of the Department of History of the State University of New York, Long Island Center. You can imagine our state of affairs as a result. We leave Sunday for Colorado where I am committed to teach five or six weeks. Then we will return to Lincoln to sell our house and prepare for the move to New York.

First, I suggest that any manuscript which you send me for checking should be sent to me here at the Department. They will know where to forward it to me. As soon as we have things arranged, I'll provide you with more definite address arrangements. Secondly, I am certain that Nebraska will designate someone else to be responsible for the relationship with El Colegio. You'll get word about that either from the University or from Dr. Olson when he arrives later this month.

Thanks for taking care of the microfilm. I have turned the shipping bill and El Colegio's bill for the box over to the Library for payment. I hope they take care of it promptly.

I am enclosing a check to cover the cost of the two volumes which you were good enough to obtain for me.

Lastly, I am afraid that this job change will prevent my planned two week trip to Mexico in August. Accordingly, I will have to ask someone to arrange for photocopying some material which I will need for the volume I will be doing for D.C. Heath on the Mexican Revolution (its a problem volume-readings representing different points of view of the status and results of the Revolution). I'll write further about this.

Dear Luis:

We are here for a brief stay (until July 26) while I teach a five weeks summer session and the whole family enjoys the mountain air and scenery. Probably the reason we are enjoying it so much is that it reminds us somewhat of Mexico.

I am writing because I need a big favor and I need it done as quickly as possible. You will probably recall my writing that I had agreed to do a volume in the D. C. Heath Problems in Latin American History series under the overall editorship of Lewis Hanke. This booklets provide the student with selective and edited readings on some historical problem. Secondly, in connection with this same project I need a copy of the following:




This letter will serve a number of purposes. As you can see we have arrived in New York. By the end of this week, we'll be settled in our house (address: Bayview Avenue, East Setauket, L.I., N.Y.). My office address will be the above from September 1st.

Secondly, a professional acquaintance, Professor J. Gregory Oswald of the Dept. of History of the University of Arizona would like to have an opportunity to meet with Lic. Cosío while in Mexico for five or six days between August 20th and 30th. Professor Oswald has been evaluating Soviet writings on Latin America and will spend next year at Ohio State University investigating even more deeply in this area with emphasis on Soviet writings related to Mexico. If you can assist him in arranging for an interview with Lic. Cosío I would be most appreciative.

Thirdly, I hope that you haven't run into difficulty in obtaining copies of the articles I needed from the Hemeroteca Nacional. If you sent them to Nebraska, they will be forwarded. If you haven't mailed them yet, please send them to my home address if mailed this month or to the office if mailed later. I am anxious to get to work on the translation of the material, so I would appreciate your expediting this. As soon as you know the cost involved, advise me and I will send you a check.

Fourth, what has happened to the Hemerografía? I haven't seen any further manuscript since I was in Mexico. Also, when you do send it, I will need a corrected list of abbreviations for the periodicals. I am getting somewhat concerned about the long delay in getting this work published. After all, almost four years have elapsed since our cutoff date (Dec. 1958). Please advise me of the state of the editing and the schedule for publication.

Muy estimado Don Daniel:

I probably am the bearer of stale news since you undoubtedly are aware that I have changed my position and moved from Nebraska to New York. Effective September 1 my office address will be: Department of History, Long Island Center, State University of New York, Stony Brook, L.I., New York. I will be serving as Chairmen of the History Department. Our new home address is indicated above.

It was not an easy decision to make, but the New York position seemed to offer the greater challenge and opportunity. I am sure that Jim Olson has informed you of Nebraska's determination to continue to develop its program of Latin American studies in general and its relationship with El Colegio in particular. I sincerely hope that the program will grow and prosper.

Before leaving Lincoln I spoke with Bruce Nicoll of the Press about your book. You will recall that the Press had applied to the Translation Committee of the Association of University Presses for funds to publish English editions of the Historia Documental and of Los Estados Unidos contra Porfirio Díaz. While the response was affirmative on the former, the Nebraska request was turned down on your book on the grounds that it was too specialized! Nevertheless, on my recommendation and recognizing the outstanding merit of your book, Nebraska Press will go ahead and publish the English version of your book. Mr. Nicoll indicated that he would be writing you about it shortly.

While in Lincoln we had a brief opportunity to see the Cronons. I told him what you had said about being patient about arranging a Spanish edition of the Daniels book. You will recall that you asked me to remind you about the matter after a month or two. Also in Lincoln, we saw Jim Olson when he made his brief visit in July. At that time we learned the good news of your acceptance of the invitation to serve as luncheon speaker at Chicago. This represents a real coup for the Conference on Latin American History, and I am looking forward to hearing and seeing you at that time.

One final matter. Aside from a brief report from Luis Muro that work on the indices for the Hemerografía volumes was continuing, I have had no other information on the progress towards publication and have seen no additional sections of the typed manuscript. I am naturally preoccupied about the long delay in publication and hope that steps can be taken to expedite publication this year.

I hope that this finds you and your family in good health. Lee joins me in sending fondest regards to all of you.

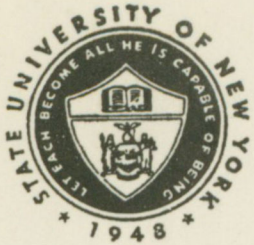

Debes disculparme el no haber podido escribirte antes de hoy día, no por descuido sino debido al recargado trabajo que tengo como secretario.

Como supongo ya lo habrás sabido, la Srita. Cubas se casó en septiembre y se fue a Europa con su marido, hijo del Dr. García Máynez. 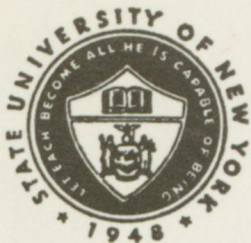

Dear Luis:

I had just finished checking the manuscript when your letter arrived today. I am sorry that it has taken me so long to check through the manuscript pages which you sent me. I have not received the second package of entries to check. According to my records, I am missing the entries prior to 05467 as well as those from 06397 to 06654 and from 06834 to 10938. While I have found lots of errors, which are indicated on the enclosed pages, there are some general points to be made.

1. Where a pseudonym is used, sometimes the real name of the author is indicated and sometimes it is not. Also, when the real name is given sometimes it is enclosed in parenthesis and sometimes not. I believe that a consistent policy should be followed--i.e., give the real name when available and enclose it in parenthesis.
2. When there is a series of articles and there are several bearing the same number we use letters with them. Sometimes these are in capitals and sometimes in small letters. Again, I think, we should be consistent and prefer the small letters--i.e., Va, VIh, etc.
3. When dates are consecutive we have decided to take the first and last date and use a dash. This is not done consistently. Also, when a publication is a weekly and consecutive numbers appear, sometimes a dash is used and sometimes not. I believe that a dash is not needed in these latter cases.
4. Do you think it wise to end the first volume at category VIII (with VIII A, etc., coming in volume II) or would it be better to break it at the end of category VII B.
5. I believe that subdivision categories introducing each section ought to be given fully--i.e., V B 3) not merely 3); VI D not merely D.

Now for other matters. I was sorry to learn that the pressure of your duties had prevented you from obtaining the copies of the material which I had requested. I am afraid that to process a request through Sierra would involve a long delay. Lewis Hanke is pressing me to do my volume and I need those selections desperately. I believe that all of the selections are available at the Hemeroteca Nacional and that copies (photostat) could be obtained by calling the Director, Dr. Pérez. Please try this method and advise me immediately how you make out. I could write directly to him, but I feel that it will get done more promptly at the request of El Colegio. As soon as you advise me of the cost involved, I will send you a check covering the expenses.

I was delighted to receive your letter of January 21. First, let me say that I was sorry to learn that your mother had been ill, but pleased that she has recuperated and that you are able to return to your work. I informed Earl Fariiseau of the reason for the delay in receiving your section of HLAS No. 25. I also forwarded your vita and the questions to our friends at Columbia University. Today I received a reply.

They, of course, were delighted to get your expression of interest. They stated that the fall semester of 1964-65 would be a good time from their point of view for the seminar on the Mexican Revolution. Regarding your knowledge of English, they stated that if you were to do some polishing during the next fifteen months, they didn't see why you would not be able to handle a seminar of graduate students, many of whom would have some knowledge of Spanish. They didn't believe that it would be necessary to send copies of your publications since practically all of them are available in the library there. Before too long they should be writing directly to you and if more information is needed they will ask for it. I gave you a good strong recommendation and I certainly hope that something will come of it. It would do the Columbia program a great deal of good and I am certain that you would benefit greatly from the opportunity.

I had heard a rumor of Dr. Zavala replacing Don Daniel. I sincerely hope that El Colegio continues to move forward under his direction. The institution already enjoys a unique place in Latin America and, as one who regards it as his "other home", I wish to see it continue its outstanding character. Selfishly, I hope the change will not further delay the publication of the volumes on Hemerografía.

As for our coming to Mexico, I fear that it will be longer than we would like. I had planned to come last August, but had to give up the plan when I changed positions. My responsibilities in a developing institution make it impossible for me to take off during the academic year. Now I have been named Acting Dean of the College of Arts and Sciences which further limits my ability to get away. While this is a temporary arrangement, as the title indicates, it will last at least until a permanent president is designated for the institution. I retain the Chairmanship of the History Department, but a deputy will act in my place while I am in the Dean's office.

UNA HISTORIA DOCUMENTAL PARA MÉXICO

Stanley Robert Ross

For a number of years ~~North~~<sup>Variety</sup> American Universities have found documentary readings to be an effective device for the teaching of history.<sup>1</sup> Not only do such collections serve as an invaluable pedagogical aid<sup>#</sup> for the professor, but the student finds the contemporaneous materials more interesting and challenging. In fact, in this manner the student begins to learn something of the nature and problems of historical literature and, in a sense, becomes a living testimonial to the accuracy of the perceptive observation by the late Carl Becker that "everyman is his own historian".

Almost five years ago, recognizing the potential value of such teaching aids, the Commission on History of the Pan American Institute of Geography and History approved a resolution urging that such collections of documentary readings be prepared for the national history of each Latin American country. The pilot effort in this respect has been published recently in Mexico.

A group of distinguished Mexican historians, with whom this writer was privileged to collaborate, undertook to prepare una historia documental de México, covering the history of the country from prehispanic times to the present. Miguel León Portilla and Alfredo Barrera Vázquez were responsible respectively for the sections on the nahuatl and maya cultures. Luis González y González prepared the material related to the



Conquest. The 16th and 17th Centuries were the task of Ernesto de la Torre Villar, while María del Carmen Velázquez contributed the material dealing with the Enlightenment. The documentary section on the Independence War represented Ernesto de la Torre's second contribution

The multi-faceted national history from the close of the Independence Struggle to the initiation of the ~~Revolution~~ Revolution of 1910 was the assignment of Moisés González Navarro. This scholar had to select and edit materials related to the era of Santa Anna, the reform movement, the Maximilian empire, and the modern epoch of Mexican history from la república restaurada through the Porfiriato. Lastly, the contemporary era (la Revolución Mexicana) was assigned to this writer.

Each section of this work is preceded by an introduction in which the contributor outlines the major developments of the period in question, ~~and~~ synthesizes its significance and provides a <sup>specific and</sup> selective general bibliography. Similarly, each document, whether reproduced in part or whole, is introduced by a brief explanatory paragraph and followed by a specific source reference. A limited number of maps, charts and illustrations have been included to further ~~serve~~ serve the needs of students.

The completed work consisting of <sup>almost 1200</sup> ~~almost one thousand~~ printed pages has been published in two volumes. The first volume ends with the section on the 18th Century, leaving the period of national history from the Independence struggle to date for the second volume.



This two volume original edition in Spanish appeared as part of the Serie Documental being published by the Instituto de Investigaciones Históricas de la Universidad Nacional Autónoma de México.

This undertaking was truly the result of an international collaborative effort-not only in terms of the binational participating scholars, but also in terms of supporting institutions. The project received support from the Rockefeller Foundation in the form of funds for stenographic assistance and released time for investigators. El Colegio de México placed its superb facilities at the disposal of the group.

While the initial publication is in Spanish and is ~~intended for use in courses~~ <sup>principally</sup> in Mexican history in the preparatory schools and institutions of higher learning in this country, arrangements have been completed for the publication of an English translation by the University of Nebraska Press under a grant from the Rockefeller Foundation-sponsored translation program of the Association of American ~~University Presses~~ University Presses. This translation should broaden the use of the documentary history in North American universities. Lastly, there has been some discussion of the possibility of preparing a one volume edition of especially selected material for the use of secondary students.

Accordingly, Mexico now has una historia documental. If the experience abroad can be taken as typical, Mexican professors and teachers have gained a valuable teaching tool.

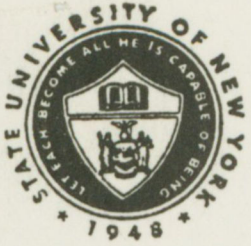

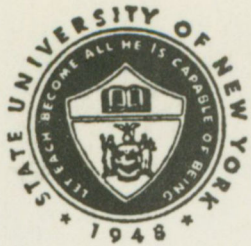

Please forgive me for imposing on you so soon, but there is a matter which I feel calls for urgent attention and the most rapid resolution possible. You undoubtedly are aware that during 1958-59 I spent fifteen months at El Colegio de Mexico working in association with the Seminario sobre la historia contemporánea de México on the preparation of a multi-volume critical guide to the hemerografía of the Mexican Revolution. This effort was supported by a grant from the Rockefeller Foundation with the understanding that El Colegio would publish the results of my efforts.

When the task was completed, it was found that the work would be prohibitively costly in its final form. So, an editorial worker was assigned to reduce the total volume to manageable size. It was planned to put the two volumes in the press as soon as the three volumes on "libros y folletos" by Luis González y González and his collaborators had been published. This has not been the case, and one delay has followed another.

I am very anxious that this work which was so consuming of my time and efforts as well as those of others should see the light of day. I believe that this work represents a very significant contribution to scholarship in the field and should be made readily available to investigators.

A few scholars who have had access to our fichas have told me how invaluable the guide is.

Lic. Cosío wrote me early this year that the first volume definitely would go to press by the end of January. This apparently has not happened. This year will mark the fourth since the work was completed. Also, since we took December 1958 as the terminal date for articles to be evaluated, we soon will have a gap of five years in the material covered. I find myself professionally embarrassed by the lack of publication of a major undertaking completed several years ago.

I fully appreciate the financial burden which this publication imposes on El Colegio. However, I believe that the institution has an obligation to me and to the Foundation and I hope that ways and means can be found to meet that responsibility. Since I know that it takes at least three months to see each volume through the press, I am presuming to urge that the process be started at once.

I sincerely hope that you will not consider my request unreasonable because I feel that I have been very patient relative to this problem over the past few years.

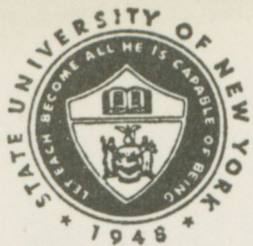

Frankly I had expected to hear from you or Dr. Zavala long before this. I am disappointed and distressed that there has been no confirmation that my work on "hemerografía" is actually in press. I know that there have been problems involved in financing publication and in regard to persons doing the editorial and indexing work. Nevertheless, I believe that the elapsed time is now excessive.

Several months ago I wrote Dr. Zavala expressing my concern on this matter, but have had no reply. I presume that money was budgeted at the beginning of this year for this purpose. In view of the fact that El Colegio's publication program is continuing, I cannot understand why works completed long after mine have appeared in print while my effort continues to be postponed.

Needless to say, I feel that the volumes on "hemerografía" represents a distinctive and important contribution to the field. I believe that El Colegio has a commitment both to me and to the Rockefeller Foundation to see the undertaking through to completion. If it has taken this long to process the first volume, when could we reasonably expect to see the second volume in print?

I would very much like to know what is happening. I think that I have been very patient and am entitled to definite information regarding the publication dates of the work.

The academic year is over. It's been a very demanding year, but one of good progress. As Acting Dean my appointment carries through the summer months, excepting four weeks of vacation, and I am hoping to get some writing done. I am afraid that my scholarly endeavors have suffered since I moved into the dean's office.

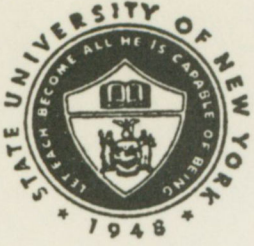

Dear Luis:

I am sure you can imagine how disappointed I was by the contents of your recent letter. I cannot say that the disappointment was unanticipated since the repeated delay in the publication of this work has been an on-going subject of concern. In view of the time which has elapsed since I completed the undertaking, I am sure that you can understand my pre-occupation whether it will ever see the light of day.

Those two volumes represent a tremendous investment—two full years of my lifetime, not to mention the time and devoted efforts of those who worked with me, and considerable expenditure of money by the Rockefeller Foundation and by El Colegio de México. Aside from such considerations, I firmly believe that the volumes represent a distinctive and significant contribution to scholarship in the field. Under these circumstances it is particularly painful to see the results of these efforts gathering dust in the boxes.

I undertook this assignment at the request of El Colegio and of the Rockefeller Foundation with the definite understanding that publication would follow within a reasonable time. I recognize that a tremendous expense is involved, but that certainly was anticipated. You will recall that I was informed in 1961 that my volumes could not be put into press at that time because there was not money enough during that year, but that the following year's budget definitely would include the publication costs for my work. Indeed, there was talk of having two printers so that the final volumes of Luis González's work and mine would be published in fast succession. Such was not the case. What distresses me most is that El Colegio continues with its publication program while postponing fulfilling this commitment.

Since I have a very strong personal interest in seeing this effort

come to fruition, I will presume to make a couple of Suggestions. First, I want to urge that the editorial and indexing work of the second volume be pushed to completion now so that when financial arrangements are completed for printing the project can be carried to prompt completion. Secondly, would it be possible to work something out with the people at the Ciudadela for the joint publication by El Colegio and the Biblioteca de Estudios Historicos de la Revolución Mexicana?

I would appreciate your keeping me informed promptly about developments. Please communicate my views to Dr. Zavala, as well as assuring him of my continued esteem.

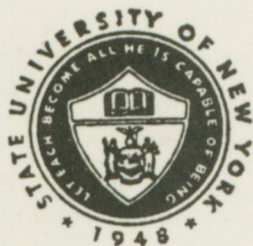

Let me know how things are going. I am kept busy here, but as you can see I am giving top priority to getting this manuscript checked so that we can all see this to its conclusion.

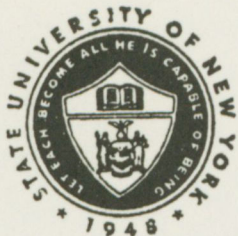

I have today mailed to Alicia Bazán the corrected pages of the manuscript including Fichas No. 14759-16509, together with pages of items to be verified etc. Since I corrected the section of the manuscript from 16509 through 18,3++ while I was in Mexico, only the last third of the manuscript from 18,3++ through 27,+++ remains to be corrected by me. Since there are about 9000 fichas to be checked, I would suggest that you send me the remaining fichas in three successive packages of about 3000 fichas each one or in four packages about the size of the one which I have just returned. Each time I notify you that a corrected section has been returned, you can ship me the next section until we have finished the task.

I was disappointed but not surprised to learn that Alicia-- according to her last letter during November had only finished about 6000 fichas. This is a long way from completing the number of fichas agreed upon for the first volume. Your estimate for the publication of the first volume already has proven optimistic and mine will soon be so. It seems to me that it is obvious that she will need help--perhaps Lilia can do some of this work once she is available in addition to working on the index. Perhaps the college can find the funds to hire Alicia's father part-time to expedite matters.

You know that I am depending on you to expedite matters-- now that funds are available for publication and all concerned agreed that the object is to get the two volumes out as soon as possible. At the present rate it would seem to me that it will be another four to six months before even one volume is


out--and goodness knows when the second volume would be completed.

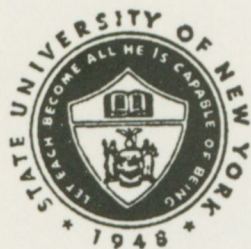
