

Dear Dr. Reyes:

I have the honor to inform you that at a meeting of the Board of Trustees of The Rockefeller Foundation held April 6-7, 1948, action was taken providing up to \$53,000 to the Colegio de Mexico toward its programs for advanced study and for training of personnel. The fund is in addition to the Foundation's current grant to the Colegio (RF 44134) and is available until June 30, 1952, with the understanding that payments under both grants will not exceed \$17,000 in any one year.

It is our understanding that of the fund thus provided approximately \$24,200 will be used for individual research aid grants, each of these grants being matched by an equal sum provided by the Colegio; and that approximately \$28,800 will be allocated for fellowships.

If it meets with your convenience, payments under this appropriation will be made on a semi-annual basis after receipt at the beginning of each year of a copy of the annual budgets for the programs toward which this contribution is made. We shall appreciate receiving also annual statements of receipts and expenditures. Any balance unexpended as of June 30, 1952, will revert to the Foundation.

Your kind letter of April 7th informs me of the action taken by the Board of Trustees providing up to \$ 53,000 to El Colegio de México towards its programs for advanced study and for training of personnel.
