Dear Dr. Cosío Villegas:

For some years the Joint Committee on Latin American Studies of the American Council of Learned Societies and the Social Science Research Council has endeavored, through conferences, research grants and other means, to advance the development of research on Latin America and to further communication among scholars in North and South America. It has, for example, held conferences on research and training in the fields of economics and sociology in which specialists from both continents have taken part.

In the summer of 1963 the committee sponsored a Seminar on Latin American Studies, which reviewed the status of these studies, principally in the United States, and suggested some opportunities for their improvement.

The papers written for the seminar deal with research in several social science disciplines, history and law. They have been edited by Charles Wagley, Columbia University, and published in the volume entitled Social Science Research on Latin America (New York: Columbia University Press, 1964), a copy of which is being sent to you separately.

While these papers have had the benefit of comments by historians and others in the United States, the committee considers that it might be of mutual interest to Latin American scholars to examine critically these papers which were prepared for another audience.

The committee therefore proposes to hold a conference to bring together a number of Latin American and United States scholars for discussion of the theme of "The Social Sciences in Latin America." The documentation for the conference, all of which would be available in advance, would consist, firstly, of the above-mentioned book; secondly, of papers, each written by a Latin American scholar, in the form of a substantial critique of one of the book's chapters; and thirdly, of papers on the general theme of the conference by Latin American scholars from different disciplines.

We are happy to say that the conference will be held in collaboration with the Centro Latino Americano de Pesquisas em Ciências Sociais. The place of meeting will be Rio de Janeiro, and the time: March 29, 30 and 31, 1965. Official languages of the conference will be Portuguese and Spanish. Participants will include the authors of papers in the book, authors of comments on those papers, authors of the general papers, and a few additional persons from Latin American countries and the United States.

On behalf of the Joint Committee on Latin American Studies, we would like to invite you to write a paper, in the language most congenial to you, on the theme of "The Social Sciences in Latin America," from your point of view as an historian. We are inviting three other Latin American scholars to write similar papers from the points of view of other disciplines. We are able to offer you an honorarium of three hundred dollars for the preparation of your paper.

The expenses of travel and of hotels and meals during the conference will be reimbursed by the committee.

We hope that you may find it possible to take part in the conference in accordance with this invitation, and we await with interest your reply.

Dear Dr. Cosío Villegas:

I am very glad indeed to know from your letter of January 8 that you are inclined to accept the invitation to write a paper on the social sciences in Latin America. ✓ We had not regarded this as a research paper.

On the question of writing a paper from your point of view as an historian, the Joint Committee on Latin American Studies regards history as one of the social sciences while recognizing, of course, its place among humanistic studies. We should be interested in your judgment on such questions as: new trends in historical writing in Latin America or, if you wish, in Mexico alone; the relationship between historical writing and the development of nationalism; the limited number of critical bibliographies of Latin American statesmen and diplomats; the apparent rising importance of social as distinct from political history; and problems of access to historical materials. These are, of course, only illustrative suggestions and you may find others in the chapter in Social Science Research on Latin America by Stanley J. Stein. *biographies*

Dear Miss Muller:

Thanks for your good letter of February 12th and accompanying check for \$33.20.

I have given up the idea of understanding the way a travel agent figures out the cost of your transportation. My own in this case had suggested the route Austin-San Antonio (Trans-Texas or Braniff) and San Antonio-México (Braniff), which is shorter than the one proposed by your agent: Austin-Houston-Mexico City. So, the latter should logically be higher.

As to hotel reservations in Rio, the Gloria, old as it is, seems perfect if, as I suppose, the meeting will take place at the Gloria. 

Apenas si me he permitido hacer algunas correcciones, pocas de ellas importantes. En la página 5 me he permitido sustituir hors d'oeuvre por aperitive, si bien reconociendo que esta palabra en inglés suena un poco raro. El hecho es que hablo de despertar el apetito, función reservada (fundada o infundadamente) al aperitivo, pues los hors d'oeuvre principian ya a saciar el apetito. También tiene un cierto sentido de coquetería culinaria la sustitución de cooks (pág. 9), por chefs, palabra ésta de un uso muy general en inglés.

De más fondo son las siguientes correcciones. Si usted encuentra indispensable hacer la referencia personal, hay que usar el nombre de Cline; de lo contrario, habría que quitar el de Naylor y dejar esa referencia de un modo impersonal.

En la página 11 me he permitido poner no mexican en lugar de no one por suponer que si alguien de habla española está interesado o podría estar interesado en escribir una historia de la guerra de Texas sería el mexicano, a quien le corresponde la mayor responsabilidad en esto. La única corrección realmente importante es la de la página 13 en donde se tradujo hacienda (land system) con el sentido de una explotación agrícola grande, por finance, o public finance. Entiendo que es de un uso perfectamente aceptado entre los historiadores norteamericanos la palabra hacienda, escrita así en español, con el sentido de una explotación agrícola grande; de lo contrario, quizás habría que usar la palabra latifundio.

Por cierto que no dejaría de interesarme que me diera usted el nombre de la persona de Naciones Unidas que hizo esta traducción y lo que usted le ha pagado por ella, pues no deja de ser frecuente mi necesidad de traducir cosas mías al inglés para usarlas en conferencias o reuniones en Estados Unidos.

You may recall that at the Conference, I requested that papers for the conference not be published prior to their appearance in the volumes planned for publication in Brazil and the United States. The reason for this request was that the policies of publishers in the United States differ on this point, and at the time we had no arrangement for publication of the English version of the papers.

I am glad to inform you now that the Columbia University Press has accepted the papers, in English, (after seeing slightly more than half of them) and that it has no objection to their being published separately, providing proper notification is given at the time that the paper will be published as one of several in the forthcoming volume by the Press. We have, accordingly, responded affirmatively to a request from Américas for permission to publish the paper by Luis Escobar Cerda.

If you do plan a prior publication, please ask that the editor of the journal request permission from me, so that the form of the notification, for copyright purposes, may be duly followed.

We have received seven translations into English of the total of eleven papers and the Introduction, and expect to receive the remaining five early in November. We propose to send each author two copies of the volume in English, and 100 copies of his chapter, as an offprint, in English. If the authors return the corrected English translations rapidly, it may be possible to secure the final volumes in the spring of 1966.
