HOW TO USE THIS REQUEST LIST

This list has been compiled by the staff of the Latin America Bureau, NCWC, Washington, D.C., at the request of the Pontifical Commission for Latin America, Vatican City. It represents official petitions for Sisters from Right Reverend Ordinaries of Latin American Dioceses with occasional requests from major superiors of religious communities in Latin America. Most of these petitions have been submitted through the Papal Nunciatures in Latin America which have been encouraged by the Holy See to do everything possible to increase the religious personnel in their respective countries.

It is desired that the greatest possible use be made of this and similar lists.

Primary purpose of this list

The primary purpose of this list is to provide information to Mother Generals and Mother Provincials and their Councils who, in keeping with the appeal of the Holy See, are considering possible fields for apostolic action in Latin America.

Antecedent to using this list, a given community might ask itself the following questions:

1. What are the particular fields (primary or secondary education, hospital work, clinics, home nursing, social welfare, etc.) in which the community by its homeland experience is prepared to labor?
2. What are the financial conditions under which the community is prepared to take up work?
3. What particular administrative circumstances (v.g., previous involvement in Latin America of European provinces of the community) may influence the choice of the country in which the community will work?
4. What socio-geographic factors in the community's U.S. activities might influence the planning (urban rather than rural work, Portuguese rather than Spanish language areas, etc.)?
5. Is the community in a position to accept a hardship post in an area of difficult climate, of primitive living conditions, of a poverty-stricken economy unable to provide any support?
6. Is the community prepared to meet a major need in any given country by undertaking a form of activity heretofore not attempted by its members?

With answers to these questions at hand the superiors are urged to select projects on the Request List likely to prove suitable for consideration. These may be discussed by mail or telephone with the Permanent Secretariat of the Women's Conference or with the Director of the Latin America Bureau who under ordinary circumstances will propose contact with the Pontifical Commission and ecclesiastical authorities prepared to advise the community on how best to serve the Church in Latin America.

The Pontifical Commission recommends that when the selection of possible projects has been made the community either send a qualified representative to Latin America for on-the-spot negotiation with the authorities or name a non-member acceptable to the community to act for it.

Supplementary uses of this list

In addition to serving for the selection of fields of labor, religious communities of Sisters are encouraged to consider further uses for this request list.

1. Copies of the list may be distributed throughout the houses of the community to make known to the members the extent and variety of the needs of the Church in Latin America as expressed by the requests of the Bishops;
2. Copies of the list may be employed in novitiates for demonstrating the types of work for which the Latin American Church seeks the services of Sisters;
3. Copies of the list may be employed in institutions of education, in nurses' training schools, in vocational and fund-raising programs for illustrating the urgency of enlisting and supporting the community's candidates to the Sisterhood.

SISTERS REQUEST LIST #1 - EDUCATION

Request #1 - Argentina, Archdiocese of Cordoba (Date: August, 1962 - Nunciature, Buenos Aires)

PROJECT: Community of 4 Sisters to operate a primary school in the city of Cordoba.

Background Information on the Archdiocese: Located in the Province of Cordoba in central Argentina. The landscape is typical basin and range similar to the Great Basin region of the United States. The climate is dry and temperate. Population of the Archdiocese is 1,258,000 with 1,080,000 Catholics.

Project Description: Sisters are needed by the opening of the term in March, 1963, for the Colegio Nuestra Senora del Carmen. The school now has 260 students through the third grade level. It is hoped that the whole primary cycle can be completed in time. The Sisters will be assisted by lay teachers already employed in the school.

Area Description: Cordoba is a modern city reputed for its warmth of faith. Its population is 600,000. All means of modern communication are available. Franciscan Sisters from Lemont, Illinois, and Sisters of St. Casimir of Chicago have missions in the city.

Present Facilities: This is a new parish with a school building next to the parish house. Until a home can be built for the Sisters, a provisional residence will be used.

Finances: The Archbishop explains that sufficient financial help will be given by parishioners.

Request #2 - Argentina, Diocese of Santiago del Estero (Date: June, 1962 - Nunciature, Buenos Aires)

PROJECT: Community of Sisters to begin primary and secondary schools for boys and girls.

Background Information on the Diocese: Located in the Province of Santiago del Estero in northern Argentina. The Diocese encompasses 145,670 kilometers in a slightly elevated plains area. The Province is divided by the rivers Salado and Dulce. The territory east of the Salado is often wooded while that to the west of the Dulce is saline desert, including the Salinas Grandes, or salt flats. Between the two rivers there is a sufficient water supply for the nearby farming and ranching areas. The rainy season in the region extends from October to March. Also see the climate des-

cription for the Diocese of Anatumya.

The area is located on the main route from Bolivia to Buenos Aires. There are mail and telecommunications and rail connections. It is also accessible by National Highways #9, #34, #64. There are numerous connecting roads in the area. The total population of the Diocese is 487,182.

Project Description: The Bishop states that no concrete plans have yet been made. The Diocese is awaiting an offer from some community of Sisters before it can make definite arrangements.

Area Description: No details are given.

Present Facilities: No details are given.

Finances: Information is not given.

Request #3 - Argentina, Archdiocese of Tucuman (Date: July, 1962 - Nunciature, Buenos Aires)

PROJECT: Community of 5 Sisters for a new primary school in the city of Tucuman.

Background Information on the Archdiocese: Located in northwest Argentina, an important sugar cane district in the Province of Tucuman. The land is similar to that in the Cordoba region but less dry, being abundantly supplied with water by streams descending from the Sierra de Aconquiya. Winter temperature is relatively mild. Population of the Archdiocese is 850,000 with 750,000 Catholics.

Project Description: Sisters are desired for this new school beginning with the 1965-1966 school year.

Area Description: Precise location of the school has not been determined since a number of requests from localities within the diocese are being considered.

Present Facilities: An adequate residence is promised by the Archbishop.

Finances: The Archbishop states that salaries will be provided/in addition to monthly student fees.

Request #4 - Bolivia, Diocese of Cochabamba (Date: July, 1961 - Nunciature, La Paz)

PROJECT: Community of Sisters for a parochial school in Arani.

Background Information on the Archdiocese: Located in the Department of Cochabamba, Central Bolivia, on the floor of the basin of the Altiplano region between the Eastern and Western Cordilleras. This is a pleasant area at an altitude of 8,000 feet with a temperate climate. The Cochabamba Basin holds the largest concentration of settlement in Bolivia. Population of the Diocese is 607,000 with 566,000 Catholics.

Project Description: No details given.

Area Description: The town of Arani, with 10,000 inhabitants, lies about 30 miles southeast of Cochabamba, with which Arani is connected by road and railroad. A number of U. S. priests (Dominicans, Maryknoll, Missionary Society of St. James) and Sisters (Daughters of Charity, Dominicans, Maryknoll, Missionary Sisters of the Immaculate Conception) have missions in the Diocese.

Present Facilities: The existing parish house could serve as a school and as a dwelling for the Sisters. There is plenty of garden-type land around the house.

Finances: The petition states that nothing more than the house and garden can be offered to the nuns.

Request #5 - Bolivia, Prelature of Corocoro (Date: August, 1962 - Nunciature, La Paz)

PROJECT: Community of Sisters to staff a school, assist at hospital and help in parish activities in town of Colquiri.

Background Information on the Prelature: Located in West-Central Bolivia in the Department of La Paz. This southern region of the Department lies in the Altiplano. The Corocoro area is one of two clusters of population (the other is Oruro) which originated as mining centers rather than agricultural regions. From the group of mines in this vicinity comes about 90% of the copper production of Bolivia. The area rises to an altitude of 13,500 feet; the climate is cold and dry. Good roads lead north from Corocoro to La Paz and south to Oruro. Population of the Prelature is 205,000 with 200,000 Catholics.

Project Description: No details given.

Area Description: Population of the town of Colquiri is 30,000. No other details beyond those given for the Prelature.

Present Facilities: The mining company in the area has promised to build a home for the Sisters.

Finances: No information given.

Request #6 - Bolivia, Prelature of Corocoro (Date: August, 1962 - Nunciature, La Paz)

PROJECT: Group of Sisters for parochial work in five contiguous parishes in Viacha, Caquisviri, Tophoco, Patacamaya and Sapahaqui.

Background Information on the Prelature: See Request #4.

Project Description: General parish tasks would be undertaken by the Sisters in this area which is confronted with the dangers of religious indifference, ignorance and Protestantism. The region will be administered by three priests.

Area Description: The parishes cover an area of 965 square miles centering around the town of Calamarca, south of La Paz. They include 25,000 inhabitants scattered throughout the region, which is an average of 12,400 feet above sea level. Climate is cool and dry.

Present Facilities: No information given.

Finances: No data supplied.

Petitioner: See Request #4.

Request #7 - Bolivia, Archdiocese of La Paz (Date: January, 1962.)

PROJECT: Six Sisters to staff primary boys' school in La Paz.

Background Information on the Archdiocese: Located in the Department of La Paz, West-Central Bolivia, in the Altiplano, the Archdiocese lies at the bottom of a chasm facing that part of the Eastern Cordillera known as the Cordillera Real. The site of the capital city of La Paz was originally chosen for its accessibility to the chief colonial route of travel and its relative protection from the cold winds of the Altiplano. Today the location seems less practical and results in the city's being cramped for

space to grow. Although partly protected from the heavy winds of the Altiplano, La Paz experiences rapid changes of temperature and rarified atmosphere making respiratory diseases common. The altitude rises to 12,000 feet making La Paz the world's highest big city. It is not uncommon for people to show at least some signs of nervous strain at this height but relief is secured by brief periodical absences. The population of the Archdiocese is 860,000 with 800,000 Catholics. Population of the city of La Paz is 321,073.

Project Description: This six-grade primary school (in conformity with the Latin American educational system) is associated with the Colegio San Calixto, a high school, but is housed in a separate building. The school was formerly operated by the Spanish Sisters of "Amor de Dios" who have had to give up their missionary work here. Consequently there are no teachers for about two-thirds of the boys.

Area Description: Nothing given other than above for Archdiocese.
U. S. clergy and religious in La Paz: Dominican, Franciscan, Maryknoll, Resurrection and St. James Society priests; Franciscan Loretine and Precious Blood Sisters.

Present Facilities: A new building is now being built and the primary grades will be the first to use it.

Finances: No information supplied.

Request #8 - Bolivia, Diocese of Oruro (Date: August, 1962 - Nunciature, La Paz)

PROJECT: Community of Sisters for a primary school in Oruro.

Background Information on the Diocese: Located in the Altiplano or highland area of southwest Bolivia, in the Department of Oruro. The area of Oruro is one of two clusters of population (the other is Corocoro) which originated as mining centers, not agricultural regions. As a mining community, the region has been subject to major fluctuations of prosperity and of population due to the uncertain character of the business of finding and selling ores. Recently, with the rise of tin mining, the community has regained importance. Climate in the area is difficult, being cold and dry. Altitude is 11,000 to 12,000 feet above sea level. The population of the Diocese is 270,000 with 250,000 Catholics. The region is serviced by railroad and roads, including connections to La Paz. The city of Oruro connects Bolivia's agricultural district in Cochabamba with the mining district in the Eastern Cordillera by two major branches of a main rail line.

Project Description: The Sisters are badly needed for this area in which the children are completely abandoned. Specific details of the school situation are not given. Currently there are missionaries from the Oblates of Mary Immaculate working in the Diocese.

Area Description: The city of Oruro has a population of approximately 63,000 and is within three and one-half hours by road from La Paz.

Present Facilities: There is at present no building for use as a school. The Bishop will provide the land.

Finances: No support mentioned.

Request #9 - Bolivia, Diocese of Oruro (Date: August, 1962 - Nunciature, La Paz)

PROJECT: Community of Sisters to operate a hospital and a grade school, and teach religion in the high school in Challapata, Diocese of Oruro.

Background Information on the Diocese: See Request #7.

Project Description: See Request #51 for details on the hospital work. The pastor of Challapata proposes that if the community of nuns which will administer the hospital is large enough, it might provide additional help in teaching religion in the high school. In addition, the Sisters could assume direction of a grade school for 500 girls. Help is greatly needed in each of these phases of the parish life.

Area Description: The town of Challapata lies approximately 65 miles south of Oruro which can be reached by train. There are unpaved roads in the area and rail service also extends to La Paz.

Present Facilities: There is a convent with chapel adjoining the hospital.

Finances: The Pastor states that the Sisters can expect support from the faithful.

Petitioner: See Request #7.

Request #10 - Bolivia, Diocese of Santa Cruz (Date: July, 1961 - Nunciature, La Paz)

PROJECT: Community of 5 Sisters to build and conduct a primary school in the Parish of La Merced in the city of Santa Cruz.

Background Information on the Diocese: Located in southeast Bolivia in the Department of Santa Cruz. The Department's eastern plains form part of an area, shared by Bolivia, Paraguay, Brazil and Argentina, known as the Gran Chaco. The climate of the Santa Cruz city area is humid and mild whereas that of the southeast region becomes drier as it approaches the Argentine border. The hot season extends from November through February. Relatively low altitude approximately 3,000 feet.

The population of the Diocese is 323,000 with 311,000 Catholics. The area around the city of Santa Cruz is the sole region of concentrated settlement in the southeast of Bolivia. The general vast area of Santa Cruz suffers from isolation and communication difficulties. However, a new truck road unites Santa Cruz with Cochabamba. In addition, rails reach east from the city into Brazil and there is air service to other Bolivian cities and to neighboring countries. Several communities of U. S. priests (Servants of the Holy Paraclete, Maryknoll, Salesians, St. James Missionaries) and Sisters (Dominican) are working in the area.

Project Description: This school, which could begin with the first three grades, would partly alleviate the school shortage in the area. In the city of Santa Cruz there is only one parish school plus two Catholic private schools (one for boys, one for girls), both of which are overcrowded. However, there are six Protestant schools.

Area Description: The Parish of La Merced is one of a number within the city of Santa Cruz and counts 15,000 parishioners cared for by the Jesuit Fathers.

Present Facilities: At present there is no building but the Pastor is trying to obtain funds estimated at \$20,000 for construction. Within the limits of the Parish a lot of 4,000 square meters may be secured from the Jesuits by the Community which would build the school.

Finances: The school is for poor children and the Parish could not guarantee the Sisters' support. However, other such schools in the area have become self-supporting through modest monthly fees.

Petitioner: See Request #7.

Request #11 - Brazil, Archdiocese of Sao Paulo (Date: August, 1961 -)

PROJECT: Sisters to open elementary and high schools for middle class students in the Sao Paulo area.

Background Information on the Archdiocese: Located in the State of Sao Paulo in southern Brazil. Sao Paulo is the most progressive and most productive

state in Brazil, with great accomplishments in agriculture and industry. The state as a whole has abundant moisture. The average annual rainfall for most of Sao Paulo is 56 inches. In the south of the state there is no winter dry season. Temperature of coastal areas like Santos are moderately high (66° in winter to 78° in summer). On the higher parts of the plateau averages are some 10° lower.

The population of the Archdiocese is 3,650,000 with 3,300,000 Catholics. Rail service and other modern means of communication are available, especially in the area of Sao Paulo city. A number of U. S. priests (Franciscans, Oblates of Mary Immaculate) and Sisters (Bernardines, Congregation of Our Lady of the Cenacle, Franciscans, Holy Cross, Ursulines) now have missionaries in the area.

Project Description: Sisters are needed to open a number of schools equivalent to the U. S. high school and junior college levels, totaling seven grades. Schools would have approximately 100 students per grade. The ecclesiastical authorities state that the schools may be established by opening one grade at a time, each year.

Area Description: The city of Sao Paulo is modern and thriving, growing at the rate of 10,000 per month. Of the four million population in the Archdiocese, two million people are without spiritual care. Some eighty parishes have been planned and no personnel is available. Sao Paulo counts five Protestant ministers for every Catholic priest. Sao Paulo is a focus of transportation with various rail lines extending into the interior. Other modern means of communication are available.

Present Facilities: None actually exist. It is explained that the schools can begin modestly by renting a large house to service the early grades of about 100 students each.

Finances: A modest tuition fee covering operational costs can be charged. After the first year of existence, it may be possible to arrange for municipal, state and federal loans, and sometime grants can be secured. Authorities state that schools should be self-maintaining by the time the seven grades are complete.

Request #12 - Chile, Diocese of Ancud (Date: May, 1961 - Nunciature, Santiago)

PROJECT: Nuns to assume charge of La Inmaculada primary girls academy in the city of Ancud.

Background Information on the Archdiocese: Located on the Island of Chiloe in Chiloe Province on the Pacific coast. It has a geographical position similar to that of Vancouver Island in North America. The climate is mild and rainy with little variation in temperature. There is a population of 115,000 with 100,000 Catholics. The great majority of the inhabi-

tants are rural and engage in farming and fishing. The more populated areas tend to be near the seacoast areas. Some farming areas are faced with the problem of "minifundism", agricultural property divided into units so small that they cannot be worked economically. Co-operative farms are being considered for some of these regions. There is air service to Ancud and Castro, plus ships of the state-owned line, la Empresa Maritima, as well as private boats for reaching the several small islands in the Diocese. There is medical service available in four small hospitals (one to four doctors in each) and other posts. The population is of Spanish origin with only slight Indian strains. Spanish is spoken; there are no dialects. In the islands there is a tendency towards a matriarchal society since many men emigrate to other areas to find work. In general, families are numerous with five to seven children and the people are poor.

Project Description: Sisters are needed to take charge of a small girls' primary academy which must be relinquished by the Community now operating it due to lack of funds and insufficient number of Sisters. The school could be expanded to include secondary teaching. The Sisters are needed immediately.

Area Description: The city of Ancud is at the northern part of the Island of Chiloe. There is in Ancud a priest who speaks English and is the English teacher at the Colegio-Seminario of Ancud. In addition, in the city of Purrangué, 200 km. north of Ancud, there are North American priests of the Precious Blood Society. One of these priests would be able to visit the Sisters at the school once a month. This trip is currently made by plane and bus but the government has assured the installation of a ferryboat between the continent and the Island of Chiloe. When this is completed the trip from Purrangué can be made by automobile.

Present Facilities: The school building is of wood and is in good condition. There is a chapel, sufficient classroom space, patios and recreation room for the girls. The Sisters have their own rooms plus land for a vegetable garden. The land now belongs to the Community which has operated the school (Religiosas de la Inmaculada) but can be purchased by the incoming community.

Finances: The school receives a government subsidy once a year for its maintenance. It is adequate to support the Sisters' expenses for food, clothing and medical assistance.

PROJECT: Sisters to staff a fee kindergarten for 60 children; a subsidized parochial school of four grades; a projected primary and technical school.

Background Information on the Diocese: Located in the Province of Antofagasta in the northern desert region known as the Atacama. It is an area rich in industry and mining, especially copper. The area of the Diocese is approximately 120,000 square kms. Climate at coast is maritime; hot during the day and cold at night. Both coast and interior regions are barren of vegetation. Population is 230,000 with 205,000 Catholics. There are land, sea and air communications with the capital. Currently there are missionaries from the North American order, Oblates of Mary Immaculate.

Project Description: No details supplied.

Area Description: No details supplied.

Present Facilities: No details supplied.

Finances: No details supplied.

Request #14 - Chile, Vicariate Apostolic of Aysen (Date: August, 1962 - Nunciature, Santiago)

PROJECT: Group of 15 Sisters, from one or more communities, to staff a girls' secondary school for the joint area of Futaleufu, Puerto Aguirre and Chile Chico.

Background Information on the Vicariate Apostolic: Part of the Province of Chiloe on the Argentine frontier and of the Province of Aysen to its south. This area begins the southern part of Chile which changes from the open landscapes of Middle Chile to land once forested but now formed into lake country by past ice glaciers. It is comparable to the Canadian North. The climate is cold in winter, dry and pleasant in summer. The population numbers 39,500 with 36,000 Catholics. Communications include transportation by plane, horse, shuttle bus and boat on the Lake Carrera.

Project Description: Fifteen Sisters are needed to staff a girls' secondary school, whose training would include commercial subjects plus domestic science.

Area Description: Only detail given describes Futaleufu which is in the Province of Chiloe on the Argentine frontier. It experiences cold winter climate.

Present Facilities: Land is now owned for the school.

Finances: Details not supplied.

PROJECT: Sisters to establish a school in Chanaral.

Background Information on the Diocese: Located in the Province of Atacama, marking the southern limit of the Atacama desert, and experiencing an average temperature of 59° F. It is an important mining area, especially for the mining of copper. Agricultural output is limited. There are good communications with other principal cities of Chile by air, land and sea. The territory of the Diocese covers 80,000 square kilometers. Its total population is 110,000 with 90,000 Catholics.

Project Description: The Pastor of Chanaral and the Governor of the Department, with the Bishop's approval, request a community of Sisters to open a school in the parish. It would be the only one of its kind in the region and is badly needed.

Area Description: The Department is quite extensive and Chanaral has a population of 10,000 including the families of workers at the mining camp of "Andes Copper" of Barquito. The population of the camp is expected to triple when the company transfers its refinery from Potrerillos. The city of Chanaral, which is on the Pacific shore and is the head harbor of the copper mines of the region, is composed completely of working-class people. It has only one public school whose professors cannot provide necessary religious formation for the young students of the region.

Present Facilities: The parish will donate the site for the new school.

Finances: The Bishop explains that the parishioners will help finance construction of a building. In addition, "Andes Copper", a United States mining corporation, is expected to provide aid.

PROJECT: Community of seven Sisters, including qualified teachers and one nurse, to operate a primary girls' school and to aid in a clinic in the parish of Salamanca.

Background Information on the Prelature Nullius: Located in the Province of Coquimbo in the northern part of Central Chile. It lies approximately 360 kilometers north of Santiago in a fertile agricultural area, watered by the Choapa River. It experiences excellent climate in the mountain region. Its total population is 76,000 with 72,400 Catholics. The area is united by a good road to Santiago which is six hours away by bus.

There is also train service.

Project Description: A group of seven Sisters is needed to operate a primary school and aid in a clinic in the parish of Selamance in the Department of Illapel. A Catholic school is badly needed to strengthen the Church's position against continuing Communist and Protestant influence in this area which was once strongly Catholic. The Sisters are requested for March, 1964.

Area Description: The parish is located in the Department of Illapel, 360 kilometers north of Santiago. It counts a total population of some 16,000 with 4,000 as a center. Located in a fertile agricultural region, the parish covers 70 kilometers and experiences excellent climate.

Present Facilities: At present there is no school building but living quarters will be provided for the Sisters in the present parish house. Eventually, a new house will be built.

Finances: This being a new Prelature, it will not be able to finance much construction or restoration of all the churches and chapels in the parish. Therefore, a community will be needed which will be able to make additions when necessary to the house and provide new construction. At present, private schools are given an operational subsidy of 50% of the sum ordinarily spent per pupil in the public schools.

PROJECT: Six Sisters to begin a secondary school for girls in the Department of Parral.

Background Information on the Diocese: Located in the Province of Linares, south of Santiago and reached by the Central Railroad and a paved section of the Pan American Highway. Its population is 184,882 with 172,000 Catholics. It is characterized by the healthy climate of Middle Chile which experiences a temperate transition between the desert of the north and the rainy lands of the south. Its summers are cool and dry; the winters are generally mild and wet. Average temperatures of Santiago, slightly to the north are 45° in the coldest month and 68° in the warmest month.

Project Description: The school is one which is being rebuilt since the destruction of the earthquake of 1960. Its curriculum is to be built gradually, to include six preparatory courses and six courses in the humanities. The Sisters are needed for the early part of 1963.

Area Description: The only details given characterize the people of Parral as of good character and profoundly Catholic.

Present Facilities: A modern school is being rebuilt by the Bishop on 15,000 meters of ground and a house will be provided for the Sisters.

Finances: Bishop states that a government subsidy covering partial operational costs is available.

PROJECT: Community of Sisters to take charge of a new primary school in the parish of Rahue, Province of Osorno.

Background Information on the Diocese: Located in the Province of Osorno in the southern part of Chile. This area begins that region of Chile which changes from the open landscapes of Middle Chile to land once forested but now lake country. The area farther to the south is comparable to the Canadian North. Total population of the Diocese is 143,443 with 137,765 Catholics. Currently there are Jesuit Fathers of the Maryland Province working in the area.

Project Description: Sisters are needed for a primary school in Rahue which will be ready in 1962. Students from this school could later continue their training at the Colegio San Mateo operated by the Jesuit Fathers in the town of Osorno.

Area Description: No details supplied.

Present Facilities: There are sufficient classrooms in the new school and the Diocese will rent a house for the Sisters until a permanent residence can be purchased for them.

Finances: No details given.

Project Description: The Sisters are needed to teach in the parish schools and, in time, to establish catechetical centers, clinics and perform other social works.

Area Description: The parishes requesting help are the following:

- 1) Malacatancito: a convent and school will be constructed.
- 2) Cuilco: a convent and school will be built.
- 3) La Democracia: a school will be built but the Sisters will have to provide a convent.
- 4) La Libertad: a school will be constructed but the Sisters must build a convent.
- 5) Barillas: a school will be constructed but the Sisters must provide a convent.

Finances: The Bishop states that the Sisters should be able to support themselves through student fees.

Background Information on the Diocese: Located in the Department of Solola, south central Guatemala. There are 400,000 inhabitants, 385,000 of whom are Catholic. There are now Diocesan priests from Spokane, Washington, working in the area.

Project Description: Sisters are needed to operate a vocational school and primary schools in an area encompassing five small towns and including approximately 50,000 people. (This is part of a larger appeal for Sisters to aid also in social and medical work). The request is made for small groups of Sisters because of Guatemalan laws requiring the vast majority of teachers to be natives. Consequently, only two or three Sisters could teach in any one school.

Area Description: This area lies in the high country with generally pleasant climate. The days are usually warm with cool nights. The population is 95% Indian and very backward. The central areas of these parishes can be reached by car, although the outlying regions are reached by horseback.

Present Facilities: No details given.

Finances: Finances are to be arranged with Bishop Topel of Spokane.

PROJECT: Community of Sisters to open in the See City of Zacapa an elementary school and later a high school.

Background Information on the Diocese: Located in the eastern part of Guatemala with a population of 500,000, with 450,000 Catholics. The Diocese is in desperate need of priests and Sisters. For the one-half million souls in the region there are only 26 priests. There are no parish schools. Various Protestant sects are active throughout the Diocese because for so many years this part of the country was without priests.

Project Description: Bishop Luna states that what his people need most urgently is an elementary school and eventually, a high school. He believes that the city of Zacapa could be changed for the better with the instruction and example that would come from the Sisters. The people are poor but good at heart and desperately need the guidance of Catholic education.

Area Description: No details supplied.

Present Facilities: No facilities.

Finances: The Bishop cannot provide financial assistance since the Diocese is quite poor.

Project Description: A primary school is needed for about 100 students, both boys and girls. It is hoped that eventually the primary school may be extended to the secondary level.

Area Description: Nopaltepec is approximately 77 kilometers by road from Mexico City. Agricultural products of the area are the maguey plant and cereals, which are cultivated during the rainy season.

Present Facilities: The only facility offered is a provisional residence for the Sisters.

Finances: No details given.

Request #25 - Peru, Diocese of Abancay (Date: July, 1961 - Nunciature, Lima)

PROJECT: Community of Sisters to build and open new primary and high school for girls.

Background Information on the Diocese: Located in the Department of Apurimac, the rugged southern Peruvian highlands. The population, which numbers 382,000 with 370,000 Catholics, is composed mainly of small farmers and ranch workers. Both Spanish and Quechua are spoken. The climate in general is cold and the area reaches an altitude of 3,000 to 4,500 feet above sea level. U. S. clergy of the Society of St. James the Apostle Missionaries are now doing parochial work in the Diocese.

Project Description: The only details given state that the schools would include an approximate enrollment of 400 students.

Area Description: No details given.

Present Facilities: No details are supplied.

Finances: The inhabitants of the area are poor people engaged mostly in farming but the petition states that they can be counted on to help the Sisters and to pay small fees to the school.

Request #26 - Peru, Archdiocese of Lima (Date: May, 1961 - Nunciature, Lima)

PROJECT: Community of Sisters to open a primary and secondary school in the Lima suburb of Balconcillo.

Background Information on the Archdiocese: Located in the Department of Lima on the western coast of Peru. Its population totals 1,403,146 with 1,363,765 Catholics. U. S. clergy working in the Archdiocese include priests from the Carmelite Fathers, Franciscans, Marianists, Maryknolls, Precious Blood Fathers, St. James the Apostle Missionaries, Sons of Mary Fathers and Sisters from these communities: Sisters of Charity, Servants of the Immaculate Heart of Mary, Marist Missionary Sisters, Maryknoll, Precious Blood, Sacred Heart and Ursuline. There are also Irish Columban Fathers performing parochial work.

Project Description: The Maryknoll Pastor of this parish needs to open a second (combined primary and secondary) parochial school due to a recent enlargement of the parish to encompass 40,000 people. The parishioners at the far end of the parish will not be reached unless this second school is begun.

Area Description: The only details given about this parish in the Lima area are that it has been very well-administered in the past but now will actually include enough territory for two parishes.

Present Facilities: No details supplied.

Finances: The Pastor says that the Sisters would not have to assume any financial responsibility.

Petitioner: Same as for Request #25.

Request #27 - Peru, Archdiocese of Lima (Date: May, 1961 - Nunciature, Lima)

PROJECT: Community of Sisters that could help financially in beginning to build a

convent and open a combined primary and secondary school in the Lima suburb of Fray Martin de Porras.

Background Information on the Archdiocese: Same as for Request #26.

Project Description: This parish staffed by Irish Columban Fathers has a population variously estimated at 50,000 to 100,000 people, most of whom have recently arrived from the mountain towns. So far, however, there are only two Peruvian Sisters working with these people and the need for another community of Sisters is very great. Specific details on the future primary and secondary school are not given--only an emphasis of its necessity.

Area Description: This is a suburban slum area of Lima whose population includes many recently-arrived Indian squatters. Due to recently passed laws the people will be able to own the land on which they originally settled and they should, therefore, tend to become rather stable. The area is now staffed by the Irish Columban Fathers who have three parishes in operation and plan a half dozen more. The petition states that this is one of the most needy areas in Peru.

Present Facilities: There are no details given regarding a school but the Sisters would have to build a convent.

Finances: The Nuncio explains that in addition to building a convent, the Sisters would have to provide some financial aid during the first year or two after the school's opening. After this period, the petition explains, the school would pay for itself and provide funds for future expansion.

Petitioner: Same as for Request #25.

Request #28 - Peru, Archdiocese of Lima (Date: May, 1961 - Nunciature, Lima)

PROJECT: Community of Sisters to begin a combined primary-secondary parish school in Matute, a suburb of Lima.

Background Information on the Archdiocese: Same as for Request #26.

Project Description: A parochial school of primary and secondary levels is needed in this parish maintained by the U. S. Community of the Missioners of St. James if their mission apostolate is not to be seriously limited.

Area Description: This parish is located in a suburban Lima area which includes both slums and a section of federal housing. It is bordered by a parish of the Maryknoll Fathers.

Present Facilities: No details given.

Finances: Apparently there would be no financial responsibility for the Sisters. The petition states that the school in the neighboring Maryknoll parish has had great success and been able to support itself without difficulty. It has catered to the same class of people economically as that of the Matute parish.

Petitioner: Same as in Request #25.

Request #29 - Peru, Archdiocese of Lima (Date: May, 1961 - Nunciature, Lima)

PROJECT: Community of Sisters to open a combined primary and secondary parish school in the suburban Lima area of Urbanizacion Jardin.

Background Information on the Diocese: Same as for Request #26.

Project Description: No details supplied.

Area Description: This is a new area in greater Lima, near the old airport, which is rapidly filling with new and beautiful homes. It is completely neglected spiritually at present although it is expected that a group of U. S. priests will soon be able to staff the parish. It is described as an area which will develop into one of the choice residential districts of Lima, similar to San Isidro and Miraflores. The petition explains that the people here are of a class which needs to be made more aware of social justice and it would be a splendid opportunity to begin with a parochial school.

Present Facilities: No details given.

Finances: Authorities state that there would probably be no financial responsibilities for the Sisters.

Petitioner: Same as in Request #25.

Request #30 - Peru, Diocese of Piura (Date: May, 1961 - Nunciature, Lima)

PROJECT: Community of Sisters to open a combined primary-secondary school in a new parish in the town of Talara.

Background Information on the Diocese: Located in the Department of Piura in the extreme north of the country with Ecuador on the north and the Pacific Ocean on the west. Within the diocese is the center of Peru's oil production. It counts a population of 705,226. The area is watered by two rivers and produces subsistence crops and cotton. There are U. S. clergy of the Society of St. James Missionaries in the Diocese.

Project Description: This would be the only parochial school in Talara, a town of 42,000. It is needed immediately.

Area Description: Talara is within the oil-producing area of the country. The school would be in a parish newly opened by priests from the U. S. order, Missioners of St. James the Apostle.

Present Facilities: No details given.

Finances: The authorities state that there would be no financial responsibility for the Sisters.

Area Description: The only details given state that the people are poor and that they speak Spanish.

Present Facilities: The school is already in use but no details are given regarding living quarters for the Sisters.

Finances: Apparently the government handles the financial responsibilities of the school.

Request #87 - Peru, Diocese of Chiclayo (Date: July, 1961 - Nunciature, Lima)

PROJECT: Group of Sisters for "social assistance" at Parroquia del Sagrario.

Background Information on the Diocese: Located in the Department of Lambayeque, northwestern coast of Peru. The area is part of the northern oasis group where mountain water feeds sugar estates, small farms and rice crops. The region produces 75% of Peruvian rice crops. The population numbers 600,000 with 540,000 Catholics. There is a dependable water supply in the area with more sunshine than in the southern cases. The altitude is coast level.

Project Description: Details are not supplied.

Area Description: Parroquia del Sagrario is an area of 6,000 inhabitants with a city atmosphere. It has a coastal climate and altitude. Spanish is spoken.

Present Facilities: Details are not given.

Finances: The petition states that the FAC (Fraternal Ayuda Cristiana) may help with expenses.
